1. Opening Reading was led by Fr. William

3. Parish Priest introduction

Fr William noted his intention for the majority of this meeting was to return to the theme of improving the experience of 'celebration of the liturgy' as outlined in his internal-circulation paper for Item 7

4. The minutes of the PPC meeting on 28th February 2019

5. Actions and matters arising from the PPC February 2019 meeting (not itemised in the Agenda)

8) Liturgical Experience

Although further discussed within item 7 Fr William made a point of promoting his intent of publishing the future week's Mass readings in a modified form of weekly Bulletin. This to help parishioners to better concentrate on hearing (not reading) the current week's Mass readings for improved engagement.

14) Future Meetings

In response to a query, Fr William apologised for the necessity to bring forward the planned AGM from the original date (5th May) to the earlier 28th April. This change was unavoidable, due to a scheduling clash with confirmation classes.

Fr William noted that a suggestion made at this AGM (to explain to parishioners how to submit Mass Offerings) had already been published in the weekly bulletin.

All other outstanding Actions were completed, or otherwise raised as Agenda items.

6. <u>2017 Appraisal Results</u>

Fr William briefly highlighted the 2017 Appraisal results and feedback related to 'standing during the Eucharistic prayer' and 'following the liturgical actions of the priest.' These findings were flagged to influence discussions of item 7.

Fr William acknowledged some survey respondents were not supportive of the temporary standing practices he had introduced and that he would need to be respectful of these views.

It was felt that clarity in the survey might help improve analysis of results (e.g. was thought likely to be some confusion over what 'following the liturgical actions' actually meant).

7. <u>Liturgical Experience</u>

As the main item of PPC business Fr William introduced a previously circulated internal discussion paper and invited full PPC feedback on all topics on an item-by-item basis.

Fr William gave an introduction to this item then took the council through a list of possible things he might say to the parish or introduce in the mass to help with liturgical engagement. Each suggestion in the list was discussed as to whether the parish would find it helpful or not to be more actively engaged in the liturgy of the mass. Fr William noted which suggestions were recommended as helpful for the parish, with a view to taking these to the parish in forthcoming Sundays..

ACTION: ALL to consider a potential 'name' for the project/initiative to improve the liturgical experience at St Mary's.

ACTION: Fr William would further consider method and timing of exploring a trial of a shorter (2 sides A4) weekly bulletin i.e. omitting Mass readings.

8. <u>2019 Appraisal</u>

Fr William pre-circulated a draft version of the Parish Appraisal questionnaire for 2019. Lack of time meant no further discussion was possible.

ACTION: ALL members to pass e-mail feedback to Fr William re. the proposed changes to questions as proposed in the draft 2019 Appraisal questionnaire.
